M.A.K. Halliday and the context of situation
In *Cohesion in English*, Halliday & Hasan define text as -any passage, spoken or written, of whatever length, that does form a unified whole (Halliday & Hasan, 1976). A text is a unit of language in use. It is not a grammatical unit, like a clause or a sentence; and it is not defined by its size.

Context and Text - Semantic Scholar
(Halliday and Hasan, 1985: 5) According to Halliday, text is a sign representation of a socio-cultural event embedded in a context of situation. Context of situation is the semio-socio-cultural environment in which the text unfolds. Text and context are so intimately related that neither concept can be comprehended in the absence of the other.

Hasan made a theoretical distinction between "relevant context" [aspects of context encapsulated in the text], and what she called in 1973 the 'material situational setting'. 'Relevant context' she defines as "that frame of consistency which is illuminated by the language of text" and "a semiotic construct".
